Israel: State, Society, Identity

Taught in Hilary Term

There are probably few states in the world that trigger such strong opinions and emotions as the State of Israel. While these responses are generally linked to Israel's foreign relations and the Arab-Israeli conflict, this course aims primarily at "looking inside" Israel. It will introduce students to the politics, society, and institutions of modern Israel by paying special attention to the prevailing societal diversity and fragmentation as well as their political implications. In particular, the dynamics of Israeli politics, society, and foreign relations will be linked to the construction of Israel's identity (and the different interpretations of the latter) from the early days of the state until the advent of the peace process in the 1990s and its collapse.
