For all other institutions an invoice is enclosed with this notice. If your institution is not intending to renew its subscription for 2016, please inform the Membership Secretary immediately.

The dollar rate includes a sum to cover bank charges for handling foreign currency. Any American institution may pay £30.00 in sterling, but **all bank charges must be carried by the member**.
