### **Any Other Business**

### 1. Oxford City Race and SHI Relays 2010

- Scott: SHIs = Senior Home Internationals: England, Scotland, Wales, Ireland.
  We have provisionally registered the 2010 City Race for the day before the Nov Classic, which is now the SHI Individual.
  Hence the City Race will clash will the SHI relays.
  We have been asked to host the SHI relays as part of the City Race, with relays in the morning and then City Race in the afternoon. If we say no we they will put on another event at Pamber with spectator races.
- Ruth: We need to be clear that it is the City Race with the SHI relays, not the other way.

Scott:	The problems is being that most of the current club won't be here in Nov 2010. There are also concerns with competitors getting run over – more likely to take risks with traffic in a head-to-head race.
Ed:	Use Shotover for the relays?
Ruth:	Planning relays is awkward.
Ian:	We need a traffic free area. Could manage ~4km courses on the City Map without crossing major roads.
Ed:	Do the relays at Shotover, and then do the City Race in town afterwards, with everyone able to run.
Scott:	Note that the SHI relays only have 24 teams/72 competitors.
Ed:	No public focus on the SHIs, only nice for the people involved.
Ali: Ed: Ali:	Would Shotover be good enough? Yes. It will need remapping.
Ruth:	Man power is the problem.
Scott:	Finding organisers for the 2010 SHIs has been problematic so far; they will accept anything SCOA offer.
Ruth:	Get TVOC or JOK to deal with the SHIs and then do the City Race separately.
Ian: Ruth: Ed: Scott:	Who would go to Pamber instead of the City Race? Old people. Don't put on the open races. Not our decision unless we take on the organising.
Ian: Scott:	Option to move the date of the City Race. Nothing else obvious to pair it with, would not do so well on its own.
Ed: Scott:	You will get fewer runners at the City Race without the November Classic the next day. Long term, I want it to be established the day before the November Classic.

Matt:	Could possibly become a bi-annual event. Possibly get one year city centre, one year elsewhere.
Ali:	Opinion seems to be mixed.
Ian:	JOK may be willing to help if they are coming down for the City Race anyway
Ruth:	When do we have to decide?
Scott:	Pretty much now.
	I will ask TVOC about Shotover.
Ed:	I am happy to organise the SHI's at Shotover.

*People who will still be around in Nov 2010: Jenny T, Amber, Chris E, Anne, James.* 

Scott: I will follow this up with SCOA and TVOC and keep the new committee informed.
