Questions for Discussion:

- 1. Why may Rockall not have an exclusive economic zone?
- 2. An oceanographer wishes to collect samples of live organisms (i.e. marine flora and fauna) with potential medical properties in a foreign coastal area. May it do so and, if so, under what conditions?
- 3. A coastal State wishes to establish a marine protected area (MPA) in its exclusive economic zone in order to protect the habitat of depleted, threatened and endangered species. May it do so? What could be the legal basis, what the content of such a MPA?
- 4. The United States and several other countries have developed a Low Frequency Active Sonar (LFAS), which projects extremely loud, low-frequency noise to detect nuclear and diesel electric submarines. Since the use of these systems began, there have been numerous whale strandings and adverse impacts on other cetacean species. State A wishes to stop the use of LFAS in its exclusive economic zone. May it do so?
